Overview

Thailand's import and export clearance process requires the submission of a Customs Import Entry or Export Entry form. The form should be accompanied by standard shipping documents, which include a commercial invoice, packing list, bill of lading/airway bill, and letter. There are five types of importation by post: 1) By air 2) By road and sea 3) EMS 4) Registered Post 5) Normal Post Importation by Express Consignment Operators: Operated by Express Consignment Operators such as Fed Ex, UPS, DHL and TNT. Import licenses are required for the importation of many raw materials, petroleum, industrial machinery, textiles, pharmaceuticals, defense products, firearms and ammunition, and agricultural items. For Thai exporters — whether shipping FCL or LCL — getting the documentation right before your cargo reaches the port is the single most important step in the logistics chain.
