

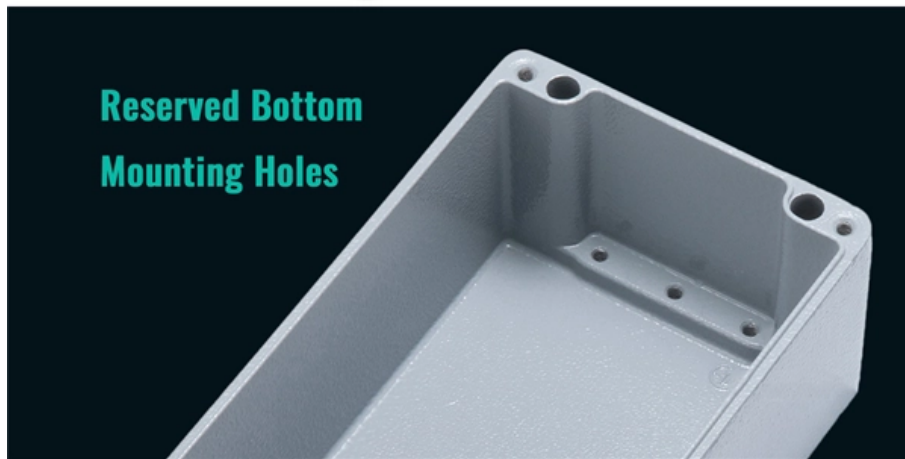

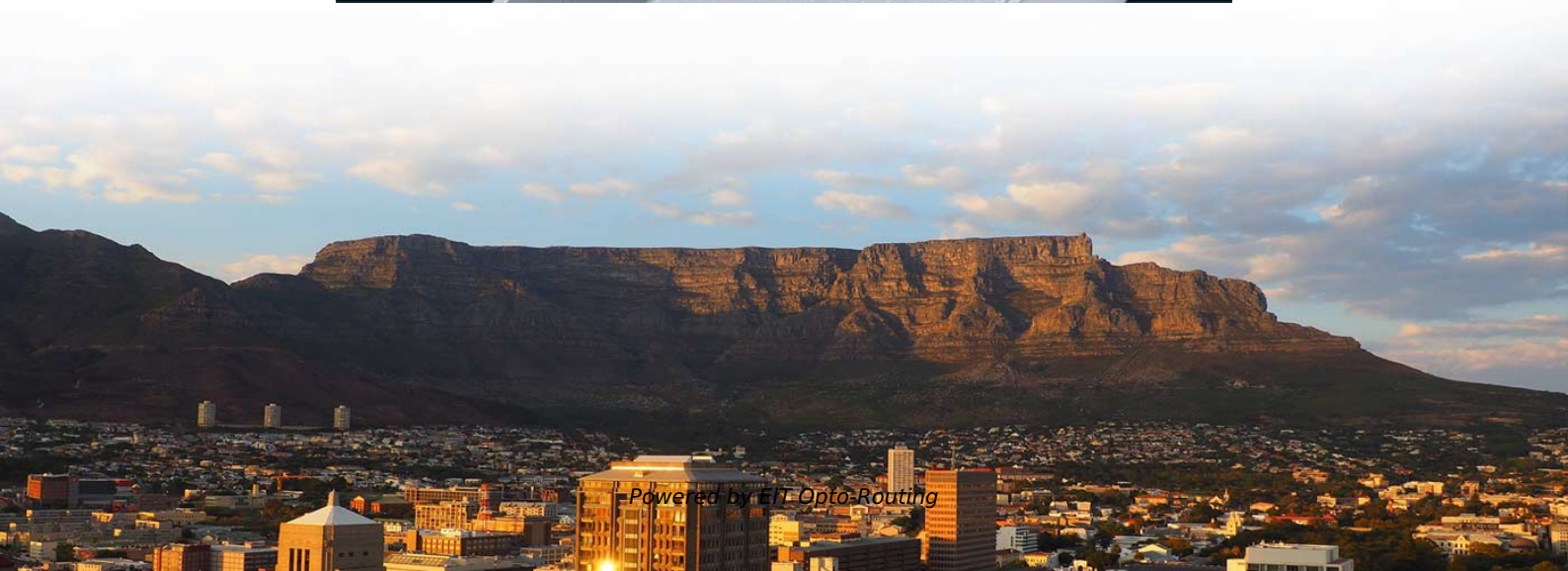

## Overview

Distribution Code G in Box 7 of Form 1099-R means your retirement funds moved directly from one plan to another in a direct rollover, and the transfer is generally not taxable.
